FROM LEGISLATIVE CHAIR JULIA WOODS:

The 2023 Texas legislative session ended May 29. Gov. Abbot immediately called for a special session to continue talks concerning property tax relief. He has since called for a second special session to continue those discussions. The deadline to sign or veto a bill was June 18. Unsigned bills automatically became law after that date. The following are a list of bills that have been signed into law, most of which will be effective

September 1:

Special 88th Legislative Session Wrap-Up

TFRW's legislative priorities this session were election integrity, education, and border security. This *Legislative Wrap-up* is intended to give an overview of the bills that TFRW focused on this session. We understood going into the session that we cannot win on everything (even if we want to)! That is not to say that some of our disappointments seemed to be no-brainer bills or resolutions that should have passed. We will hope to hear from those involved as to why these bills or concurrent resolutions never made it out of committee.

At the outset, we want to congratulate our representatives for finally passing legislation that will protect minors from irreversible gender modification procedures and treatments. **SB 14** is a thoughtful piece of legislation championed by two doctors in the legislature (Senator Donna Campbell and Representative Tom Oliverson), among others. We also congratulate our Representatives on ending the threat of future COVID-related mandates. **SB 29** prohibits governmental entities from implementing or enforcing COVID-related vaccine, mask and business or school closure mandates. Both bills were signed by the Governor on June 2nd and will be effective September 1st, 2023.

This session, TFRW issued 15 Action Alerts covering 36 bills or bill stages (some bills were in more than one alert but were at different points of the process). Those bills included (those that have become law listed first):

- <u>HB 900</u> provides regulation for library materials sold to or included in public school libraries, in particular "sexually explicit material." The bill was signed by the Governor on June 13th and is effective on September 1st, 2023.
- <u>SB 1070</u> (the "ERIC" bill or "Alan Vera Memorial Act") relates to the interstate voter registration crosscheck program which seeks to prevent duplication of registration in more than one state and to identify voters that have moved, been convicted of a felony, have died or are ineligible to vote for another reason. The bill became law by the operation of law and is effective September 1st, 2023.
- <u>SB 12</u> prohibits sexually explicit performances in the presence of a child. The bill became law by the operation of law and is effective September 1st, 2023.
- <u>SB 15</u> requires that participation in intercollegiate sports competitions be based on the student's biological sex. Last session a similar bill was passed for grades K-12. (HB 25 87(3)). The bill became law by the operation of law and is effective September 1st, 2023.
- <u>SB 1599</u> relates to ballots voted by mail. This bill adds requirements for ballots to be voted by mail that are returned at the polling place because the voter has decided to vote in person. It also adds procedures for applications for a ballot by mail that are defective. The bill became law by the operation of law and is effective September 1st, 2023.
- HB 1605 provides for the restoration of the State Board of Education's

(SBOE) authority to set the percentage of the TEKs that instructional material must cover (a mistake, even if well-intentioned, that has taken 14 years to remedy).[2] While TFRW applauds this correction, TFRW got involved with this bill because as originally drafted, it transferred to much authority from SBOE to the Commissioner of Education and the Texas Education Agency. At TFRW's request, some amendments were added to the bill that are intended to correct this problem. The bill was signed by the Governor on June 13th and becomes effective September 1st, 2023. TFRW will continue to follow the implementation of this legislation by the Commissioner and the agency.

HB 1243 provides for the increase in penalty for illegal voting back to a felony (was reduced to a Class A misdemeanor in 2021 session). This bill is very similar to SB 2 which was the subject of an Action Alert. The bill was signed by the Governor on June 13th and becomes effective September 1st, 2023.
